

DIRECTIONS

I684: Exit 8. Right on Hardscrabble Rd. Go to end of Hardscrabble & turn left onto Rt. 124. Take 1st right onto Bloomer Rd. Turn right onto Rt 121. Vail Farm is about half mile on the left.

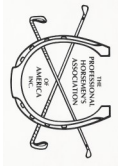
West on I84:(From Danbury CT) Exit 21, Left at end of Ramp onto Rt 121. Vail Farm is about 2 miles on the left.

East on I84: This is a clover leaf exit. Get off Exit 20 for Brewster Rt. 6 & 202. At end of ramp turn left. Go half mile and turn right onto Rt.121. Vail is about 2 miles on the left.

Outdoor Ring: 225 X 160. Sand Footing
Indoor Ring: 180 X 60. Sand Footing
Warm Up Ring: 200 X 45. Sand Footing

To show in CHJA & NEHC Medal classes, riders MUST be members of the respective organization.
